INTRODUCTION

*All during the many years that I have worked to understand the timing of the judgment coming on America, many different **TIME CYCLES** were discovered. These time cycles showed how judgments repeated in cycles, getting stronger from cycle to cycle. GOD'S LAW governed these cycles. GOD'S LAW also governed the demons in how and when they could act.*

*This section contains the text of a report that I originally wrote on July 26, 2001. In it, I explain the basics of the **12-YEAR JUDGMENT CYCLE**. I also discuss a major judgment cycle discovered in 1998 and present several examples. I have revised this report only to reflect the past tense of certain events that were written in the present tense in the original report.*

THE 12-YEAR JUDGMENT CYCLE: THE BASICS

Insight came in 1998 after years of working with shorter time cycles (1-year, 2-year, 5-year, and 7-year cycles). I understood that the judgment concerning America and this world had a 12-year cycle.

The chart (below) is what I drew up in 1998. However, there would be no opportunity to see just how this cycle worked until we got into the year 2001.

The year 2001 would be the start of the next (and third) 12-year cycle of judgment. Note that, in the chart, the previous 12-year cycles are positioned directly above the current 12-year cycle.

HOW PARALLEL WORKS

When a TIME PARALLEL exists, events that happened previously exert an INFLUENCE on the events that are yet to come. Sometimes this INFLUENCE is obvious—sometimes it is subtle.

For example: The year 1983 is parallel to the year 1995. And, both 1983 and 1995 are parallel to the year 2007. What happened in 1983? In 1983, came the primary revelation about the coming ACCIDENTAL NUCLEAR ATTACK by Russia that would result in a limited nuclear exchange between Russia and the United States in the month of December (“A DECEMBER”—the year is unknown).

Again, the chart (above) shows a simple parallel. The year 1977 is parallel to 1989, The years 1977 and 1989 are both parallel to the year 2001.

Therefore, what happened (or what was revealed by Jesus in say 1977 and/or 1989) can surface or repeat in the year 2001. The repeat is RARELY IDENTICAL to what it was in an earlier parallel year. The repeat is, however, LIKE IN SUBSTANCE to the earlier parallel year.

In 1979, Jesus Commissioned me to work to understand the timing of judgment. What I learned was much more than timing: I discovered much of the dynamic of judgment, the laws governing it, and the way that GOD’S LAW governs how it emerges or moves to culmination.

SHADOWY JUDGMENTS

I learned that, after Jesus warned of judgment, we would begin seeing SHADOWY EVENTS or SHADOWY JUDGMENTS that conformed to what Jesus said would happen. But, these SHADOWY JUDGMENTS were generally harmless—both non-lethal and not destructive. ***SHADOWY JUDGMENTS began in April 1977 and concluded by late August 1989.***

PRELUDE/PATTERN JUDGMENTS

Next, we would see what we called PRELUDE JUDGMENTS (also known as PATTERN JUDGMENTS). These also conformed to what Jesus said was coming. However, these judgments lacked the force of the full judgment. Thus, while they could be lethal and destructive, they were generally only 1% of what the real judgments would be. ***Prelude Judgments or Pattern Judgments began September 19, 1989 and concluded by August 2001.***

REAL/FULL JUDGMENTS

Real or Full Judgments began July/August/September 2001 and conclude in the year 2013.

AN EXAMPLE OF THE 12-YEAR JUDGMENT CYCLE

On June 1, 1989, Jesus told me this: **“PREPARE TO ENDURE A SHAKING IN THE EARTH IN THIS AREA, NOTHING OF YOURS WILL COME TO ANY HARM. I LESSEN THIS SHAKING FOR YOUR SAKES.”**

In a discernment effort of 1989, it was perceived that this earthquake would strike on June 25, 1989. It would be triggered by volcanic activity and would range upwards of a 6.1 Richter intensity.

We saw a PRELUDE/PATTERN JUDGMENT on June 25, 1989, when a 6.1 Richter earthquake struck Hawaii. The Hawaiian quake was triggered by volcanic activity. On June 25, 2001, Spokane, WA was shaken by a 3.7 Richter earthquake, a city we moved to in 1999. Thus, we saw that Jesus’ Word of June 1, 1989 spoke of Spokane (where we lived in 2001), rather than Mt. Vernon, WA (where we lived in 1989 when His Word came).

Jesus’ Word of June 1 pointed to an earthquake in the area we lived in that would come (as discerned in 1989) on June 25. It would be a 6.1 Richter intensity. In 1989, we lived in Mt. Vernon. Jesus moved us to Spokane in April 1999. At that time, I did wonder about His June 1, 1989 Word.

The revelation of God presented all of us with a period of MERCY (8 years) and a period of SOVEREIGN MERCY (3 more years) which ended July/August 2000. After that, the things He warned us about could begin to happen and this included His Word of 1988 about the major earthquake(s) to level much of the Skagit Valley in Washington State. Fundamentally, the year 2001 was parallel to the year 1989, so what He told us in 1989 COULD begin to surface in 2001.

On **June 25, 2001 a 3.7 Richter earthquake shook Spokane, Washington** and it was quite a jolt! We would thereafter endure upwards of 70 aftershocks in the weeks following the initial earthquake.

As Jesus told us June 1, 1989, He lessened the earthquake (from a 6.1 Richter to a 3.7 Richter) for our sakes. And, according to His Word, nothing of ours came to any harm.

The TINY STAR: A BROKEN ASTEROID

On *July 26, 1989*, Jesus said: **“IN THE HEAVENS IT EXPLODES IN A FURY, A VIOLENCE REFLECTING WHAT’S BEEN DONE AND SO THE PACE QUICKENS. FIRE IN THE HEAVENS AND FEAR ON EARTH, FOLLOWED BY TERROR AND PANIC AND YET NOT A HAIR OF MY SEALED LAMBS SHALL BE SINGED, NOR SHALL ANY HARM COME TO THEM. FOR THE SAKE OF THOSE WHO ARE MINE, I WILL SPARE MANY AND MUCH. YET TERRIBLE LOSS IS IRREVERSIBLE. IN THE NEXT 8 DAYS WATCH THE HEAVENS AND SKIES ABOVE. ABIDE IN ME.”**

In 1994 (five years later), the Comet Schumaker-Levy 9 collided with Jupiter over a period of seven days at the end of July. This is what we would call A PATTERN EVIDENCE AND WARNING that what Jesus had told me in 1989 was near.

STORMS NAMED “ALLISON”

Please note on the 12-Year Judgment Cycle chart that the year 2001 was parallel to BOTH 1989 and 1977.

- *In June 1989 Tropical Storm “ALLISON” struck Houston, Texas.*
- *In June 2001 a Tropical Storm named “ALLISON” struck Houston-Louisiana.*

Just a coincidence? Not really! This is how a parallel time will work in general terms. However, however a parallel can also be much more specific.

STORMS NAMED “CLAUDETTE”

A storm named CLAUDETTE has struck 3 times within the 12-year and the 24-year cycle. Tropical Storm CLAUDETTE struck the Texas Coastline in July 1979. 12 years later (in 1991), a Hurricane

CLAUDETTE appeared again. And, in July 2003 (24 years from 1979), a Hurricane CLAUDETTE (a category 1 storm) struck the Texas coastline (the eye came over O'Connor, Texas) on July 15, 2003 (the 30th DAY (Jesus' Word June 16, 2003)).

In brief, here are the parallel events:

1. Hurricane CLAUDETTE strikes Texas on July 15, 2003.
2. Hurricane CLAUDETTE strikes in July 1991 (12 years before 2003).
3. Tropical Storm CLAUDETTE strikes Texas in July 1979 (24 years before 2003).

SO, WHAT HAPPENED IN 2004?

In 2004, Hurricane CHARLEY moved towards Tampa, Florida on August 13, 2004 then suddenly swung some 90 miles to the south catching Floridians by surprise (killing 33). **12 years earlier**, in August 1992, Hurricane ANDREW was heading for Miami, Florida when it suddenly turned south and slammed into Homestead, Florida.

In March of 1980 Mt. St. Helens erupted for the first time in a long time. 24 years later, on October 1, 2004 Mount Saint Helens erupted again.

3 REPEATING TIME PERIODS

I have noted three distinct periods when events can repeat, these being:

1. **24 Years earlier.**
2. **17 Years earlier.**
3. **12 Years earlier.**

Here follow some of the repeat events that we have been recording and reporting since 2001, when the 12/24-Year Judgment Cycle was recognized.

The 17-year period:

The most notable repeat event was the explosion of CHALLENGER space craft shortly after takeoff. Then, on almost the same day 17 years later, there was the explosion of COLUMBIA space craft as it re-entered the earth's atmosphere.

The 24-year period:

In January 1981, a cold wave and storm swept the Midwest and East Coast areas. In January 2005, violent winter storms hit the West Coast and spread blizzards and flooding to the Midwest and East Coast areas.

June 1981, a 6.4 Richter earthquake struck central Iran killing 300. This was matched by a February 22, 2005 6.4 Magnitude earthquake that also struck central Iran killing more than 500.

In 1977, the Midwest U.S.A. baked in a sweltering heat wave, called a Bermuda High, with blistering temperatures and high humidity. This started on June 9, 1977 with a steady rise in temperatures in the Midwest reaching highs in July 1977. The heat wave ran all the way into August, 1977. Through the 12 years cycle we see that 1977 (please refer to the chart above) is also parallel to 2001. In 2001, we saw a similar blistering heat wave settle on the Midwest and over much of the nation.

The 12-year period:

In February/March 1993, a blizzard storm of the century swept the eastern half of the U.S. This matched with a vast winter storm to hit the same areas in March 2005.

On March 21, 1993, a Soviet and U.S. submarine collided off the coast of the Soviet Union. In January 2005, a U.S. fast attack submarine hit an undersea mountain in Indonesia killing 1, injuring 20, and mangling the outer hull of the sub. The December 26, 2004 earthquake and tsunami changed the topography of the ocean floor. Thus, the computer maps the sub ran by were wrong and the sub slammed into the new underwater mountain.

In 1989, we had the Exxon oil spill in Alaska. In August 2001, there was another large oil spill in Alaska (a ship sank with lots of fuel oil abroad).

July 25–27, 2001 was connected with Hurricane BARRY that swept into the Florida/Alabama areas on Monday, August 6, 2001 from the Gulf of Mexico (minimal damage, minimal hurricane). Hurricane BARRY is the 1989 version of a Hurricane CHANTAL that formed in the Gulf of Mexico at the end of July 1989 and struck the Texas/Louisiana coastline by August 1, 1989. Again we see another 12-year cycle repeat.

CEASE WORK: “THE JUDGMENT IS HERE AND IS NOW”

The 12-Year Judgment Cycle worked wonderfully and was a thing clearly governed by GOD’S LAW. However, it took an immense amount of research into past events as well as a careful work of prayer and discernment to recognize why some events repeated, why others did not repeat, and how to anticipate which would repeat and which would not.

Not every event on the 12-Year Judgment Cycle repeated. Yet, those that did were stunningly clear—sometimes even down to the names for hurricanes which in some cases reappeared 12 years later and in the same months as they first appeared 12 years earlier.

Again, the Church showed no interest nor any appreciation for the fact that those things were tailored by God to forewarn His people of what was coming. Instead, His people turned a deaf ear and a blind eye to His warnings and so ended up embracing the full judgments with all of their horrific consequences.

*In late December 2007, Jesus instructed me to “**CEASE WORK**” in understanding the timing of judgment. All work on the 12-Year Judgment Cycle was thereafter put aside.*

*When I asked Jesus WHY He told me to stop working to understand the timing of judgment, His answer was quintessential. Jesus simply stated, “**THE JUDGMENT IS HERE AND IS NOW.**”*
