### PART 9 THE REVELATION OF “17”

#### **INTRODUCTION: A CLOUDY “17”**

*Following the 1973 vision of the midwest earthquake that laid waste Chicago and many other Midwestern cities (to say nothing of the cities obliterated by the flood tide of Lake Michigan pouring down the Mississippi River), I asked FATHER GOD when this would happen. On asking this, I was shewn a “number 17” in the form of a cloud—a “cloudy 17”.*

Nancy-TONI discerned in 1993 that a massive storm system that flooded the midwest and caused the Mississippi River to rise dramatically was that STARTING POINT in time. Indeed, it was a massive system of clouds and heavy rain that caused this and in effect it was LIKE the flooding to be caused when the earthquake was followed by the pouring out of the waters of Lake Michigan.

So, we had our STARTING POINT in time: 1993.

Thus, 17 years added to the STARTING POINT is this: **1993 plus 17 years = 2010.**

### **DOUBLE & SET: GOD'S LAW**

Then, in June 2008, Jesus led me to Chicago to witness a second great flood, LIKE the great flood of 1993. The storms and flood of 2008 flood had the same effect and proved to be even more destructive than the storms of flood 1993.

We understood that we were seeing what we call a DOUBLE AND SET of a judgment pattern meaning it was now established by God and God would shortly bring it to pass. This referred to the Monster Earthquake vision of 1973.

Years earlier, the HOLY SPIRIT shewed me that Genesis 41:32 was not only an account of Joseph's Ministry in Egypt, but it was also a revelation of God's Law. ***“And for that the dream was doubled unto Pharaoh twice; it is because the thing is established by God, and God will shortly bring it to pass.” (Genesis 41:32).***

We had observed a few cases where a judgment event was DONE TWICE and in one case, involving “THE WALL”, once doubled and set by July 1989, it was a mere four months before THE BERLIN WALL fell in November of 1989. However, that work of prayer which involved “THE WALL” IN THE SPIRIT also involved “setting the captives free” which referred to those in captivity to Soviet Communism.

While the Berlin Wall fell in November 1989, it took another two years before the Soviet Union collapsed setting free half a billion living souls from captivity to Godless Communism. Therefore, the fulfillment of the vision of July 1973 (the Monster Earthquake in the Midwest) would emerge over a four month to two year period—again pointing to the year 2010.

We also understand through Jesus' Word that major earthquakes (6 to 7 Magnitude) will shake the midwestern (St. Louis/Chicago and the Region) well BEFORE the Monster Earthquake, which would destroy the Midwestern U.S.

While we expect “something” to happen in 2008 (it is September 2008 as I write this section of the report), we do not perceive that the major earthquakes will strike the Midwest this 2008.

As happens so often with a prophetic revelation that is BOUND, while we have some answers to questions of timing, the answers invariably ask new questions that cannot be easily answered. We also know that, from a given point in time, the full judgment itself will run three years start to finish. We have not yet entered that three-year period, so the judgments we are seeing now are preliminary and lead to the full judgment.

### **CEASE WORK**

This is as far as I carried the issue of the timing of judgment before Jesus instructed me to cease that work.
